



25-Year Limited Warranty on PVC Whiteboard cabinet carcasses



Your LimeTree Alfresco® Outdoor Kitchen cabinets (excluding finished fronts) come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the LimeTree Alfresco® Outdoor Kitchen cabinets repaired or replaced if the LimeTree Alfresco® Outdoor Kitchen cabinets product fails to be of acceptable quality and the failure does not amount to a major failure. Nothing in this warranty is intended to limit any condition, warranty, right, or remedy available pursuant to any Australian legislation, except to the extent permitted under such legislation.

With your new LimeTree Alfresco® Outdoor Kitchen cabinets come the quality assurance provided by the 25-Year Installed Limited Warranty (the “Warranty”). The Warranty is offered to you by LimeTree Alfresco Pty Ltd of 81 Watts Road, Mornington, VIC, 3931 Australia. Phone Contact: 03 9786 4168. This Warranty applies to the owner of a permanent installation of LimeTree Alfresco® Outdoor Kitchen cabinets only when installed by a LimeTree Alfresco Certified Fabricator and/or Installer and following all LimeTree Alfresco recommended procedures for fabrication and installation (the “Installation”). Subject to the terms of this document, LimeTree Alfresco warrants to the owner of the Installation that LimeTree Alfresco will repair or replace, without charge, Outdoor Kitchen Cabinets (the “Product”) if the Product fails due to any manufacturing defect during the first 25 years following initial installation. This Warranty applies from the date of completion of Installation for a period of 25 years thereafter subject to the following conditions:

1. The Installation is completed after 1st March 2013 and is for residential use in Australia
2. The Installation has not been moved from the original place of Installation.
3. The LimeTree Alfresco Outdoor Kitchen Cabinets are maintained according to the LimeTree Alfresco Care Brochure (the “Care Brochure”). A copy of the Care Brochure may be obtained free of charge by contacting LimeTree Alfresco (“LimeTree Alfresco”) on 1800 119 115 or by visiting www.limetreealfresco.com.au. Failure to follow the instructions in the Care Brochure may void this Warranty.
4. The Product will not decompose or delaminate.

5. This Warranty DOES NOT COVER: a. Physical, chemical, or other abuse including any use of the Installation that is unreasonable considering the normal and expected uses of such an installation in a residence, for example, this Warranty does not cover; damage from vandalism, use of improper cleaning solutions, damage from leaving substances such as bleach or drain cleaner on the product without prompt cleaning, damage from dropping heavy objects on the LimeTree Alfresco Outdoor Kitchen Cabinets. Damage caused by excessive heat, for example, exposure to heat to such a degree that white marks/rings, cracks, or scorching marks appear. CAUTION: Damage to the LimeTree Alfresco Outdoor Kitchen Cabinets around a hot plate or BBQ may appear where (i) cookware that is on or partially on a heating element is permitted to overhang the benchtop causing excessive heat build-up or (ii) from using high temperatures for excessively long periods of time. c. Any damage to the LimeTree Alfresco Outdoor Kitchen Cabinets caused by or arising out of improperly installed, used, or maintained appliances (including garbage disposals) which are either built into the LimeTree Alfresco Outdoor Kitchen Cabinets or placed or stored in the LimeTree Alfresco® Outdoor Kitchen cabinets d. Damage caused by acts of God, or other incidents/occurrences beyond the control of LimeTree Alfresco, including without limitation, fire, theft, storms, and floods. e. Flaws in the appearance of your LimeTree Alfresco® Outdoor Kitchen cabinets material is caused by workmanship or fabrication and installation techniques that are not in accordance with LimeTree Alfresco's recommended procedures for fabrication and installation. f. Damage caused by post-installation settlement, swelling, or changes to the underlying substrate or structure. g. The performance of any adhesive, caulk, or other accessory or failure of filled joints or seams.

6. The Installation must be fabricated and installed following all LimeTree Alfresco specified procedures for the fabrication and installation of LimeTree Alfresco® Outdoor Kitchen cabinets

7. LimeTree Alfresco will repair or replace any area of the Installation that has a product manufacturing defect covered by the terms of this Warranty. If repair is not possible, LimeTree Alfresco or your authorised agent will replace the defective area of the Installation. LimeTree Alfresco will pay for: a. the cost of the LimeTree Alfresco® Outdoor Kitchen cabinets. b. Labour involved in the removal and replacement of the original installation of the LimeTree Alfresco® Outdoor Kitchen cabinets. c. plumbing and electrical connections. You will be responsible for any other costs associated with or arising out of the repair or replacement.

8. LimeTree Alfresco cannot guarantee that the colour of any material used to aid a repair will be an exact colour match to the existing Installation. Slight variations in batches of LimeTree Alfresco® Outdoor Kitchen cabinets material may occur.

9. In the case of either a repair or a replacement occurring under this Warranty, the Warranty will continue from the original date of the Installation and not from the date of the repair or replacement.

10. To qualify for repair or replacement, the owner must provide the original sales receipt or other documentation acceptable to LimeTree Alfresco which demonstrates proof of purchase of the LimeTree Alfresco® Outdoor Kitchen cabinets, clearly showing the date of purchase, address of the Installation and that the Installation was performed by a LimeTree Alfresco certified installer.

11. Your LimeTree Alfresco® Outdoor Kitchen cabinets product may suffer varying degrees of wear and tear, including scratches and staining during normal use. This is not a defect in your product.

12. This Warranty is transferable from a previous homeowner to a new homeowner within the 25 - year period from the original Installation.

13. Any modification to the LimeTree Alfresco® Outdoor Kitchen cabinets product post its installation may void this Warranty.

14. No representative, dealer, or salesperson of any other party is authorised to make any warranty or promise on behalf of LimeTree Alfresco with respect to the LimeTree Alfresco® Outdoor Kitchen cabinets product. No terms or conditions other than those stated herein or provided by law, and no agreement or understanding, oral or written, in any way purporting to modify this warranty shall be binding upon LimeTree Alfresco unless made in writing and signed by an authorised employee of LimeTree Alfresco.

15. This Warranty is governed by the laws applicable in Australia. The courts of Australia shall have exclusive jurisdiction over any dispute arising out of or in connection with this warranty.

16. To obtain service under this Warranty please contact LimeTree Alfresco Head Office.

17. To be eligible to make a claim under this Warranty, LimeTree Alfresco or its authorized representative must be allowed to conduct reasonable testing of the Product and review of the claim, including, without limitation, visual inspection of the Product, taking samples of the Product and conducting testing of the Product and any samples.
